I/We understand and acknowledge that discipline must be a combined effort between home and the College. Together we seek to train the heart and foster moral development. I/We fully trust and support the College in this area and agree to notify the College if at any time I/we can no longer support the College in its discipline and policies.

**MEDICAL AUTHORITY**

I/We are fully confident that the utmost care and vigilance will be taken by supervisory staff to ensure my child’s safety and welfare. In the event of some untoward or accidental happening resulting in injury or loss or damage of personal belongings, I/we accept full responsibility and will in no way seek liability upon Mildura Christian College or its staff. In case of injury or illness sustained by my/our child, I/we authorize the College to determine and obtain appropriate medical attention for my/our child and if necessary reimburse the College for costs incurred.

**EXCURSIONS/CAMPS**

I/We give permission for my/our child to attend all official excursions. I/We understand that special permission will be sought for overnight camps. I/we understand that the cost of excursions will often, but not always, be covered by tuition fees and an additional fee may be levied. Camps and Student Conventions are an additional expense.

**PERMISSIONS**

**FINANCE**
